Easy Ways to Join The Legacy Society!

- Leave a percentage or specific dollar amount to East Ridge at Cutler Bay Foundation in your will or Trust.
- List East Ridge at Cutler Bay Foundation as a beneficiary of your IRA or a life insurance policy.
- Fill out a 'transfer on death' (TOD) form to donate investment or banking account balances at your passing.
- Create a charitable gift annuity with the Foundation that pays you income during your life and leaves the remaining balance to East Ridge. Contact us for a free proposal.
- Work with your attorney to create a charitable trust that pays you income during your life and donates the remainder to East Ridge at your passing.

- Use your estate plan to create a named endowment fund (minimum gift of \$10,000) with earnings each year going for a purpose you select at East Ridge at Cutler Bay.
- Talk with us ahead of time to see if an estate gift of real estate or certain property such as antiques, artwork or jewelry would be accepted.
